Meeting Summary Items Specific to IM Monitoring Activities

Affiliated Monitors, Inc., serving as the independent monitor (IM), provided information related to the following topics: status of the IM's website development, activities related to monitoring (i.e., hospital site visits, community meetings, individual meetings with local leaders and EMS personnel), and analysis process utilized for monitoring the Asset Purchase Agreement (APA).

Initial Monitoring Phase

Mr. Coyne explained that the monitoring process was underway, and the AMI team was engaged in the review of documents and the interview phases. Although AMI had only been appointed as the IM in April, the team wanted to host six community meetings, which had been set in June in the following locations: McDowell County (Marion), Yancey-Mitchell Counties (Spruce Pine), Buncombe County (Asheville), Transylvania County (Brevard), Macon-Jackson Counties (Highlands), and Macon County (Franklin).

Website Development

The IM website was functional, as of May 31, 2024, and a contact email address for AMI had been posted. The website continues to be developed and, when completed, will provide a web-based reporting form and a hotline feature in English and Spanish. The website will also afford those who speak other languages access to an interpreter.

There were no complaints from patients received to date via the email address provided on the IM website.

Meeting Summary

DHT, through Rachel Ryan, advised regarding deadlines set by the APA for correspondence from DHT to HCA regarding Potential Non-Compliance.

Affiliated Monitors, Inc., serving as the independent monitor (IM), provided information related to the following topics: status of the IM's website development, status of reports received by the IM Website portal, and the status of ongoing community engagement.

Website Development

The IM website became functional on May 31, 2024. Within the past week, the website's "Submit a Complaint" feature became operational. The feature was demonstrated to those in attendance. Mr. Coyne also explained that the telephonic hotline is expected to be operational within one week, and that after-hour calls will be returned by AMI personnel.

Consumer Complaints

Mr. Coyne explained that due to the short period of time the website complaint function has been operational, only one complaint has been received. During the same period at least 19 complaints were received by the NCDOJ.

Community Engagement Activities

The monitoring team anticipated returning to Western North Carolina from November 12-15, 2024.¹ Mr. Coyne explained that no large public meetings are currently being planned during this visit, with the goal instead of reaching people and groups who did not participate in the community meeting process. At the present time, AMI anticipates focusing upon patients, providers and other stakeholders served by Mission Hospital in Asheville, as well as in Transylvania and Macon counties, with future visits focusing upon different regions.

Substance Use Disorder (“SUD”) Investments

Dr. Mims reflected on DHT’s SUD investments, noting that DHT invested more than \$25 million to address SUD in Western North Carolina (“WNC”) over the last 5 years because this issue is a top priority in our region. DHT funded work in harm reduction, access to treatment services and prevention efforts. Grants were made in nearly every county DHT serves to support planning for opioid settlement dollars. Dr. Mims also highlighted that while adverse outcome of SUD worsened during the pandemic, WNC fared better in part because of DHT’s investments.

Transition

Representatives from NCDOJ assured DHT and AMI that they would assist in transitioning this work to any new staff members who joined NCDOJ after the upcoming election for Attorney General.

Meeting Summary

NCDOJ Transition Process

The Office of the NCDOJ is under a transition process due to the outcome of the 2024 gubernatorial election. Llogan Walters will become the primary liaison with the NCDOJ's Office along with support from colleague Daniel Mosteller, who was introduced during the meeting. Sarah Boyce, Jasmine McGhee, and South Moore are departing the NCDOJ and relocating to positions in the Governor's Office.

Status of Reports Received to IM Website Portal & Discussion

AMI, as Independent Monitor, reported having received three complaints to date for 2024. General subject areas were limitations on visitation in the immediate aftermath of Hurricane Helene, services related to the Emergency Department, and quality of care and request for assistance with legal counsel. AMI continues to process these complaints. AMI reported having been copied on a number of reports from external sources for purposes of information sharing.

According to the NCDOJ, their Office received 122 complaints for year-to-date and acknowledged a slow-down in complaint activity during the previous two months. The NCDOJ intends to forward pertinent complaints to the IM for information and review.

Reflections on the Impact of Hurricane Helene

Resources, including water and food supply chains, in Western North Carolina (WNC) were disrupted by the force and flooding brought to the region by Hurricane Helene in September 2024. Homes and businesses were destroyed and/or severely damaged in various locations throughout the region. DHT relayed how Mission Health System provided enhanced security, food, and gasoline to employees and used vast resources to keep the hospital in Buncombe County operational during the aftermath of the hurricane. While the hospital has been working with pressurized water supplied from a recently dug well, water services have recently been restored.

Community Engagement Activities by IM for 2024 and 2025

November 2024 – The IM had scheduled an onsite visit for November 2024. However, due to the impact of Hurricane Helene on WNC and feedback from various stakeholders, the IM decided to reschedule their onsite visit for community engagement until January 2025 to be sensitive to the needs of the communities.

January 2025 – The IM renewed their outreach efforts and scheduled an onsite visit to WNC the week of January 27 – 31, 2025. During the visit, the IM team will be meeting with individuals and small groups who have scheduled time with the team. Team members will be asking for reflections for the previous year and information which may be of importance to the monitoring of the Asset Purchase Agreement (APA).

May 2025 – The IM will return in May 2025 for an onsite visit. The team intends to meet with the community and will provide dates and opportunities for meetings as they finalize plans.

Meeting Summary

Opening Remarks & Introductions

As there were new attendees representing the Office of the NCDOJ at the meeting, introductions were made by DHT personnel, the lead team members of AMI, and the three representatives of the NCDOJ. Logan Walters, the NCDOJ liaison to DHT, was unable to attend.

Community Engagement Activities (January 2025)

AMI provided an overview of their community engagement activities for January 2025, which had been rescheduled from Fall 2024 due to Hurricane Helene recovery efforts in Western North Carolina (WNC). The Team met with 12 groups and/or individuals, both virtually and on-site, from various communities in WNC. Community issues shared by community members regarding the HCA/Mission Health System aligned with previous information obtained: lack of access, emergency department wait times, and quality of care issues.

Community Engagement Activities & Restructure of Community Meetings (May 2025)

AMI announced that the Spring site visit is scheduled for May 5 – 14, 2025. The IM will be accompanying DHT for facility tours of the Mission Health System during the first week of the site visit. AMI is scheduling public meetings in two locations this year and is planning to change the format of the meetings to incorporate a panel discussion, inviting

panelists from the NCDOJ, NCDHHS, and CMS to join AMI team representatives. The goal is to provide an opportunity to share insights into the regulatory agencies and provide continuing education to the public about the process and value of regulation.

Discussion of 2025 Review Process

AMI provided an overview of their review process for the year 2024 in reflection. In addition to the community engagement meetings held in January and planned for May 2025, the Independent Monitor Team filed its *Request for Information* with HCA/Mission Health System in February with a requested due date of April 15, 2025.

Report on Consumer Complaints Received by NCDOJ

Consumer complaints are generally related to billing and access to care. Four complaints were shared with the Independent Monitor for purposes of information.

Report on Consumer Complaints Received by IM to Website Portal

One complaint had been received into the IM's website portal, and three were received by email to date. The complaints aligned with issues reported by other consumers. AMI is continuing to identify and access referral sources.

Meeting Summary

Opening Remarks & Introductions

Dan Wilkes, having recently joined the Office of the NCDOJ, was introduced to the attendees. In turn, introductions were made by DHT executives and the lead IM team members of AMI.

Community Engagement Activities (May 2025)

While onsite in Western North Carolina (WNC), the IM accompanied DHT on their tour of HCA/Mission Health facilities for the first week and met with individuals and organizations. During the second week, the IM hosted two community engagement meetings which were publicized in a number of media outlets and made open to the citizens of WNC. The first meeting was held in Marion, and the second meeting was held in Asheville.

Attendance – The meeting in Marion had less participation than expected, partially we believe due to weather conditions. The meeting in Asheville was well attended and also live-streamed. Approximately seventy individuals participated via livestreaming.

Updated Format – During AMI’s first year as the Independent Monitor (IM), AMI hosted community meetings which were opened by DHT, followed by an AMI presentation, and concluded with a Q&A session for members of the public. During AMI’s second year, the IM worked to update the format of the community meetings by inviting representatives of

regulatory agencies to meet the public via resource tables and to provide the citizens with an opportunity to share their experiences directly with the regulators.

This year, the community meetings were opened by DHT. AMI provided an overview of their work, answered questions from pre-registrants, and invited the public to meet both NC regulators, HCA representatives, DHT executives, and the IM Team afterwards at “resource tables.”

Appreciation to Representatives – AMI expressed appreciation to the NC DOJ and its representative, Michael Hawkins, for staffing a resource table. In addition, Karen Burkes represented the NC Department of Health and Human Services (NC DHHS), J.C. Sadler and Annie Carpenter represented HCA/Mission Health, and AMI and DHT staffed their respective resource tables.

General Feedback – The NCDOJ reported receiving helpful feedback from the meeting and appreciated the experience. The AMI Team reported receiving positive feedback about the new format and, for one patient, was able to meet with that individual and subsequently forwarded their HCA/Mission Health concerns to the NC DHHS.

AMI explained that individual and smaller group meetings, which were also held during the May visit, were meaningful and necessary to the monitoring process of the Asset Purchase Agreement (APA). The Team had moved intentionally to balance meetings with individuals and smaller groups alongside the larger community meetings. Based on their experience, AMI discussed the possibility of hosting one to two community meetings per year and continuing to meet with individuals and small groups. The NCDOJ voiced agreement with the IM’s approach.

Discussion of 2025 Review Process & Updates

AMI provided an overview of their review process for the year 2024 in reflection.

The monitoring process, which looks back at the preceding year, is a multi-pronged approach which includes:

- Review of HCA/Mission Health’s Annual Report – due annually on or before May 1st.
- Review of HCA’s Responses to AMI’s Requests for Information (RFI) – due each Spring.
- Participate in annual site visits with DHT to HCA/Mission Health facilities – conducted each Spring.

HCA/Mission Health’s Annual Report – The HCA Annual Report was submitted by HCA in a timely manner.

HCA Responses to the IM’s RFI – The IM Team filed its RFI with HCA/Mission Health System in February with a requested due date of April 15, 2025. HCA submitted their

Responses to AMI's RFI on May 22, 2025. AMI followed up to obtain additional information on incomplete responses and clarification on confidentiality issues. AMI is awaiting HCA's response.

Facility Site Visits —Receiving HCA's RFI response after the site visits limited the IM's ability to engage HCA/Mission Health executives and staff during the May visit in more in-depth conversations and made the site visits to HCA/Mission facilities less meaningful than last year's visits.

Next Steps – AMI anticipates that the IM Report for 2025, reflecting 2024 compliance under the APA, will be shared with the public for continued transparency of the process. DHT intends to discuss a more scheduled timeline for production of HCA Responses to the IM's RFI for the next monitoring cycle and in advance of the facility site visits.

Report on Consumer Complaints Received by NCDOJ

Since March 17th, the NC DOJ has received thirteen consumer complaints related to HCA/Mission Health. Consumer complaints received were generally related to billing, quality of care and access to the emergency department at Mission Hospital in Asheville. One complaint concerned the loss of professional liability coverage with regard to MAHEC, which is not covered under the APA.

Report on Consumer Complaints Received by IM to Website Portal

Since the last meeting, there have been no complaints received via the IM Website Portal. AMI received one complaint while at the community meetings in May. As noted above, the complaint was referred to the NC DHHS. AMI will continue to assess any complaints received and, if appropriate, submit the complaint to the appropriate regulatory agency.

Meeting Summary

Opening Remarks

Rachel Ryan opened the meeting and provided a high-level overview of the agenda items for today’s meeting.

Status of Reporting Cycle for Calendar Year 2024

The AMI Core Team visited Western North Carolina in January to conduct small meetings and in May for in-person and community-wide meetings. AMI submitted a Request for Information (RFI) in February but did not receive responses from HCA/Mission Health (HCA) until after May’s onsite visit. Despite the response timing from HCA, AMI was able to submit the Independent Monitor’s (IM) Report to DHT on time.

After distribution of the IM report, DHT hosted an opportunity for the news outlets to meet with DHT and the IM representatives to ask questions about the report and the reporting cycle.

On August 7, 2025, DHT hosted a community question and answer session in the form of a webinar to allow attendees the opportunity to hear a synopsis of the report and to submit questions for answers by the IM. Approximately sixty people attended. A link to the recording of the webinar, posted on the IM’s website, was provided to the NC DOJ.

The IM Report and Questions by AGO

The 2025 IM report covered events occurring in 2024, which required a retrospective review of past events versus current events and status. Some of the IM findings remained unchanged, as the pending lawsuit had not been resolved, the Immediate Jeopardy (IJ) citation issued by the Centers for Medicare & Medicaid Services (CMS) was still pending, and the Uninsured and Charity Care policy had been changed by HCA to remove the language exempting real property valued under \$300,000 without notification to the IM and the Advisory Boards.

The AGO and the IM discussed the RFI and HCA's response, which cited protection of the information produced by HCA under two sections of the General Statutes of North Carolina. AMI requested clarification as to which items were specifically governed by the protections cited and why. As no clarification was provided by HCA, the IM drafted the report without reference to the materials, noting that this did not affect its ability to determine compliance with the principal areas cited for potential non-compliance.

DHT intends to discuss with HCA options for an improved process for the next reporting cycle to make the responses to the RFI more meaningful and the site visits to the facilities more productive. DHT also plans to meet with HCA to discuss decreasing trends in certain service lines.

The AGO confirmed that they had reviewed the Annual Report and other documents and did not intend to issue any notice under 13.13(b) of the APA.

Plans for Continued Monitoring Activities in 2025

Patient advocacy numbers for each facility, listed on the HCA website and previously distributed by the IM to the community, appear to no longer be active.

The IM intends to follow up with an onsite visit to Western North Carolina in the fall and is working on specific dates.

Report on Consumer Complaints Received by NCDOJ

The NC DOJ has received six new consumer complaints related to HCA/Mission Health. Consumer complaints received were generally related to quality of care and billing issues.

Report on Consumer Complaints Received by IM to Website Portal

Since the last meeting, there have been no complaints received via the IM website portal. AMI received one phone call, which sought assistance in reaching the appropriate regulatory agency. The caller was provided with contact information for the NC Department of Health & Human Services (NC DHHS). AMI will continue to assess any complaints received and, if applicable, submit the complaint to the appropriate regulatory agency.

Other Business

There was a settlement reached in the federal antitrust lawsuit between HCA and four plaintiffs, City of Brevard, City of Asheville, Buncombe County and Madison County. The State antitrust lawsuit remains pending. The details of the settlement were discussed briefly.

Meeting Summary

Opening Remarks

Rachel Ryan opened the meeting, and each attendee introduced themselves. The team welcomed Allyson Barkley, who is new to the Chief Deputy’s Office and has recently joined the NC DOJ team to work with DHT matters.

Status Update of 2024 Compliance Cycle

DHT reported that their notice of potential non-compliance was delivered to HCA on or about October 24th and in advance of the deadline established by the compliance cycle.

Reflections on Community Engagement Activities in Fall 2025

The IM Team continued their outreach efforts to individuals and small groups. During the fall, the IM has focused on connecting with Seller Representatives of the Local Hospital Advisory Boards to schedule virtual meetings for discussions and to gain insight.

In October, the IM met with one group of Seller Representatives and found the meeting to be productive. The IM has issued invitations to the Seller Representatives of the remaining boards to schedule virtual meetings.

Plans for Community Engagement Activities in 2026

The IM and DHT have discussed conducting community engagement meetings in early spring, possibly as early as March. Preliminary plans are to host one meeting in Buncombe County and to schedule another meeting in a local hospital community.

The IM anticipates that the format will be similar to the meetings held in May 2025, as the structure encouraged members of the public to submit questions in advance and to meet with state officials, as well as the IM, at resource tables. The NC DOJ agreed that the format was productive and allowed access to state regulators.

A planning meeting between the IM and DHT is scheduled for later in the week. After dates have been decided, invitations will be sent to state regulators, as well as to HCA/Mission, to participate in community engagement through the resource table format utilized in May.

Report on Consumer Complaints Received by NCDOJ

The NC DOJ received nine new consumer complaints related to HCA/Mission Health during the current quarter to date. Many of the complaints were about billing issues, with others being about nurse staffing and quality of care.

The NC DOJ intends to share the redacted complaints with the IM.

Report on Consumer Complaints Received by IM to Website Portal

There were no new complaints received via the IM website portal or other reporting mechanisms, including phone and email. The IM attributed the lack of volume to a growing understanding by consumers about regulatory agencies and their statutory authority to process their concerns and, when appropriate, take enforcement action.

Other Business

DHT will circulate an email to schedule the first quarterly meeting of 2026.

Meeting Summary

Opening Remarks

Rachel Ryan opened the meeting and welcomed Heather Parlier, Senior Vice President of Operations for Dogwood Health Trust, who then addressed to the group. Llogan Walters introduced the NC DOJ team.

Reflections on Community Engagement Activities in Winter 2026

The Independent Monitor (IM) Team, which usually combines their community engagement activities with facility site visits later in the year, moved their small group and community meetings to March 9 and 10. The earlier meetings were designed to gather insights closer in time to Year 2025 under review and to share real-time information about their ongoing process with the community.

Small Group and Individual Meetings – During the March visit to Western North Carolina, the IM Team scheduled and met with four (4) groups and one (1) individual. The meetings were productive and allowed the IM to engage with individuals to exchange ideas and information.

Community Meetings – In coordination with DHT, the IM Team also hosted two community meetings, one in Brevard and one in Asheville. The meetings were publicized in local

media outlets, and attendees were invited to pre-register and provide questions to the Independent Monitor which would help to inform their presentation. [Questions which were outside of the scope of the IM Team's purview to answer were forwarded to representatives at HCA/Mission, the NC DOJ, and NC DHHS for information purposes. Comments, which appeared to be patient-related complaints, were separated, and the IM leadership team contacted those individuals for follow-up.]

During the IM's presentation, the Team delivered updates about the monitoring process, reflected on their current activities, and discussed remaining activities under the monitoring timeline.

In addition to presentations by DHT and the IM Team, the format was enhanced to include an educational component featuring Lee Miller, Deputy General Counsel NC of the Department of Health and Human Services (NC DHHS). Mr. Miller spoke at both community meetings and provided an overview of the survey and enforcement process for hospital complaints.

Following the presentations, the IM invited the attendees to visit Resource Tables for one-on-one conversations with representatives: NC DHHS (Lee Miller and Julie Cronin – General Counsel and Acting Chief of Staff and Deputy Secretary for External Affairs), NC DOJ (Michael Hawkins – Outreach & Policy Advisor for the Public Protection Section), HCA/Mission Health (J.C. Sadler – VP of Marketing & Corporate Affairs and Annie Carpenter – AVP of Community Engagement), and the IM (Gerald Coyne, Denise Moran, and Jeff Brickman).

The community meetings were well attended, and the meeting in Asheville allowed for remote viewing via live streaming. Copies of the video and slide deck from the meeting in Asheville were uploaded to the IM website for access by the public.

Plans for Continued Community Engagement Activities in 2026

The IM continues to identify individuals and groups for conversations, either virtually or in-person during onsite visits. The IM Team is in negotiation for dates with one group and is connecting with another group of individuals for conversation. The IM website remains updated with an invitation to connect via the IM email address.

Plans for HCA/Mission Health System Site Visits in 2026

DHT is discussing plans for onsite visits to HCA/Mission Health System facilities. The IM has planned to accompany DHT. Specific dates have not been finalized.

In collaboration with the IM, DHT is working with HCA representatives on improvements for data responsiveness. The requests include providing responses to the IM's *Request for Information* timely and in advance of the facility visits and scheduling interviews with identified key facility staff members, which will make the visits more productive.

Report on Consumer Complaints Received by NCDOJ

During the first quarter, the NC DOJ received 19 new complaints, including five complaints commenting specifically about the Immediate Jeopardy matters. Of the remaining 14 complaints, three were for billing and eleven were for quality-of-care issues (e.g., emergency treatment, post-surgical). The NC DOJ intends to share the redacted complaints with the IM.

Report on Consumer Complaints Received by IM to Website Portal

There were no new complaints received via the IM website portal during the first quarter.¹

As referenced above, there were nine entries submitted by registrants via the registration process for the Community Meetings and identified by the IM as being specific to patients and patient care. The IM Team made attempts to contact each of the registrants to discuss their concerns. When appropriate, the individual was provided with contact information to the appropriate organization and/or agency.
